MEMBER UPDATES

Kristen Gingery - Morgan County, WV

During the 2020-2021 school year, the Morgan County Partnership and Morgan County Schools administered the PRIDE Survey to students in 6th through 12th grade at Warm Springs Middle School, Berkeley Springs High School, and Paw Paw Schools. The data reported is representative of the 6th-12th grade population of the schools and communities in Morgan County, WV. A total of 493 students completed the PRIDE questionnaire.

The PRIDE Survey is a national evaluation that measures student alcohol, tobacco and other drug use. Results of the survey provide comprehensive descriptions of the self-reported drug use patterns of area youth in addition other attitudes and behaviors known to be related to alcohol and drug use/misuse (e.g. family characteristics and participation in community or school events).

The table below presents the 2020-2021 results for five key measures of substance use/misuse for Morgan County, West Virginia.



"SUBSTANCE USE AMONG RELIGIOUS AND NONRELIGIOUS YOUTH"

Abstract: Among a predominately Mexican and Mexican American sample of preadolescents, religiosity protected against lifetime alcohol, cigarette, and marijuana use and recent alcohol and cigarette use when religious affiliation was controlled. When religiosity was controlled, however, adolescents with no religious affiliation and adolescents who were religiously affiliated reported similar substance use outcomes. Interaction effects demonstrated that the protective effect of greater religiosity operated more strongly in some religions than in others for selected outcomes. Overall, the impact of religiosity on reported drug use did not differ significantly for more and less acculturated Latino youth.

"SYRINGE DISTRIBUTION PROGRAMS DURING THE OPIOID OVERDOSE CRISIS"

With the continuing severity of the opioid crisis in the past decade, more restrictive opioid prescribing policies have reduced the overall availability of prescription opioids, which, in turn, has inadvertently led to an increased use of illicit drugs such as heroin. These illicit drugs are associated with higher rates of overdose, serious infection, and disease transmission since they are often injected, while prescription opioids are taken through pills. To combat this issue, syringe services programs (SSPs) have been implemented and shown to increase proper disposal of used needles, reduce rates of HIV and HCV among PWID, and further encourage treatment for PWID. It is recommended for state governments to begin implementation of SSPs but there are many state policy barriers, among other problems, that challenge this initiative.
